CHRISTMAS TREE RECYCLING

Collection Begins Monday, January 11

Trees Must be at the Curb No Later than
Saturday, January 16

The collection of live Christmas trees for recycling
in Baltimore County will take place over
a two-week period, beginning Monday, January
11.

To ensure collection of Christmas trees, residents
must have the trees out at the curb no
later than Saturday, January 16.

Residents must follow these simple rules when
placing their Christmas trees at the curb to be
recycled:

- Only set out live (not artificial) trees.
- Set out the tree only (no lights, decorations,
tinsel, bags, tree stands, etc.).
- Only set out trees at the front curb or street;
trees will not be collected from alleys.

Residents who wish to drop off Christmas trees
themselves may do so starting Saturday,
December 26, 2015. Christmas trees (no lights,
decorations, tinsel, bags, tree stands, etc.) may
be taken to any one of the County's three drop-off
locations.
